PROFESSOR PATRICIA UBEROI

Dr Patricia Uberoi was born in Canberra, Australia, but has lived and worked in India for almost 50 years. She received her early education in New South Wales country schools, and went on to do her B.A. (Hons.) and M.A. degrees in Oriental Studies from the Australian National University, Canberra, specialising in Far Eastern Languages and Civilizations. Her M.A. dissertation, based on library research under a Commonwealth Scholarship at the University of Hong Kong, was a literary biography of the modern Chinese poet, Wen Yiduo. She completed her Ph.D. degree in Sociology from the University of Delhi in 1981 with a dissertation on the Chinese New Culture Movement.

Dr Uberoi has held teaching and research posts in the Department of Asian Civilization and the Department of Far Eastern History of the Australian National University; at the Indian Institute of Advanced Study, Shimla; at the Department of Sociology of the Delhi School of Economics; and from 1986 to 1993 in the Centre for the Study of Social Systems, Jawaharlal Nehru University, New Delhi. She was Reader and then Professor of Social Change and Development, Institute of Economic Growth, Delhi, from 1993 to her retirement in 2007; Honorary Director of the Institute of Chinese Studies, Centre for the Study of Developing Societies (2004-09), Delhi; Nannerl O. Keohane Distinguished Visiting Professor at the Department of Anthropology, University of North Carolina (2009); and Radhakrishnan Visting Professor at the National Institute of Advanced Study, Bangalore (2010). She is currently Chairperson and Honorary Fellow of the Institute of Chinese Studies, where she heads the India liaison office for the Track II Bangladesh-Chin-India-Myanmar (BCIM) Regional Forum as well as the liaison office for the BCIM Economic Corridor Joint Study Group of the Government of India.

Dr Uberoi is currently engaged in research on family, kinship, marriage, gender and sexuality, and on aspects of popular culture and social policy in reference to both India and China. She has published widely on these themes, including *Freedom and destiny: Gender, family and popular culture in India* (Oxford University Press, 2006); a popular and well-regarded text, *Family, kinship and marriage in India* (edited, Oxford University Press, 1993); *Social reform, sexuality and the state* (edited, Sage

Publications, 1996); *Rise of the Asian giants: Dragon-elephant Tango* (edited, Kolkata, Anthem Press, 2008); and, most recently (with Kishan S. Rana), *India's North East States, the BCIM Forum and Regional Integration* (Institute of Chinese Studies, 2012). She has also co-edited *Tradition, pluralism and identity: In honour of T.N. Madan* (Sage Publications, 1999); *Anthropology in the East: Founders of Indian Sociology and Anthropology* (Permanent Black, 2007); and *Marriage, Migration and Gender* (Sage Publications, 2008). She was Book Review editor (1988-96) and Co-editor of the prestigious sociology journal, *Contributions to Indian sociology* (1992-2006), and is on the editorial board of several other academic journals, including *China Report*.
